Explore New Zealand

The Emerald Lakes

The Emerald Lakes are located on The Tongariro Alpine Crossing in Tongariro National Park, New Zealand, it is considered to be the most popular one-day hike in New Zealand, throughout the entire hike there is astounding volcanic scenery. Probably the most amazing part of the hike (nearly 20 kilometers) of Tongariro Alpine. Tongariro National Park is the oldest national park in New Zealand, located in the central North Island. It has been acknowledged by UNESCO as a World Heritage Site of mixed cultural and natural values.

The Hobbiton Movie Set

The Hobbiton Movie Set was a significant location used for The Lord of the Rings film trilogy and The Hobbit film series. It is situated on a family run farm about 8 kilometres (5.0 mi) west of Hinuera and 10 kilometres (6.2 mi) southwest of Matamata, in Waikato, New Zealand, and is now a Tolkien tourism destination, offering a guided tour of the set. Guided tours of the 5.5 hectares (14 acres) movie set site commenced in 2002 and continue to be provided daily. The two-hour excursion is very popular, and advance bookings are recommended.

Waitomo Caves

The Waitomo Caves is a village and solutional cave system forming a major tourist attraction in the northern King Country region of the North Island of New Zealand, 12 kilometres northwest of Te Kuiti. The community of Waitomo Caves itself is very small, though the village has many temporary service workers living there as well. The word Waitomo comes from the Māori language wai meaning water and tomo meaning a doline or sinkhole; it can thus be translated to be water passing through a hole. The caves are formed in Oligocene limestone.

Milford Sound

Milford Sound / Piopiotahi is a fiord in the south west of New Zealand's South Island within Fiordland National Park, Piopiotahi Marine Reserve, and the Te Wahipounamu World Heritage site. It has been judged the world's top travel destination in an international survey and is acclaimed as New Zealand's most famous tourist destination. Rudyard Kipling had previously called it the eighth Wonder of the World. Bottlenose dolphins swim under rainbow. Seals, penguins, bottlenose dolphins, and whales are increasingly observed due to recoveries of each species.

Franz Josef Glacier

Franz Josef Glacier / Kā Roimata o Hine Hukatere is a 12 km (7.5 mi) long temperate maritime glacier located in Westland Tai Poutini National Park on the West Coast of New Zealand's South Island. Together with the Fox Glacier 20 km (12 mi) to the south, and a third glacier, it descends from the Southern Alps to less than 300 metres (980 ft) above sea level. The area surrounding the two glaciers is part of Te Wahipounamu, a World Heritage Site park. The river emerging from the glacier terminal of Franz Josef is known as the Waiho River.
